11	OF NORTH CENTRAL FLORIDA, INC. THE CHILD CENTER
12 13	MERIDIAN BEHAVIORAL HEALTHCARE, INC. PREVIOUSLY
13 14	ENTERED INTO BY THE ALACHUA COUNTY BOARD OF COUNTY COMMISSIONERS, FINDING A PUBLIC PURPOSE AND
15	PROVIDING AN EFFECTIVE DATE.

17	WHEREAS, the Children's Trust of Alachua County was created by Alachua County
18	Ordinance 18-08 and approved by the voters on November 6 th , 2018; and
19	WHEREAS, the Board of County Commissioners had previously approved, by way of its
20	purchasing ordinance and procedures, contracts for certain services related to the population of
21	children from birth to 5 years old; and
22	WHEREAS, these contracts were let to bid through a public process and approved by the
23	Board of County Commissioners at a public meeting; and
24	WHEREAS, §22.11(15) of the Alachua County Code of Ordinances otherwise known as
25	the Purchasing Code allows for the purchase of services without a bid if offered on the same
26	terms and conditions as those given to another government organization; and
27	WHEREAS, the Children's Trust of Alachua County has adopted the Alachua County
28	Purchasing Code as its interim purchasing procedure; and
29	WHEREAS, the Children's Trust of Alachua County has been advised that the Board of
30	County Commissioners will not be funding these contracts after September 30, 2019; and
31	WHEREAS, the Children's Trust of Alachua County wishes to assume these contracts on
32	the same terms as the Board of County Commissioners for one year terms with a potential one

1	year extension; and
2	WHEREAS, the Children's Trust of Alachua County finds that assuming these
3	agreements are within their authority and serve a public purpose, they hereby resolve as
4	follows:
5 6 7 8	 The contracts with Healthy Start of North Central Florida, Inc., The CHILD Center, and Meridian Behavioral Healthcare, Inc. previously entered into by the Board of County Commissioners are hereby assumed by the Children's Trust of Alachua County.
9 10 11	The Interim Chair of the Trust and the Interim Treasurer of the Trust are hereby authorized and directed to sign and attest to the contracts upon adoption of this resolution.
12	SECTION 1. Effective Date. This Resolution shall become effective upon approval by
13	the Children's Trust of Alachua County.
