RESOLUTION RELATING TO MEMBERSHIP INTO THE FLORIDA RETIREMENT SYSTEM

The Children's Trust of Alachua County of
Alachua County, Florida, in lawful session and in regular order of business properly presented, finds that:

WHEREAS, the policy and purposes of the Children's Trust of Alachua County of Alachua County, Florida, to extend to the General Employees of said Children's Trust of Alachua County, not excluded by law, the benefits of the Florida Retirement System, on the basis of applicable State laws and amendments thereto, and rules and regulations, authorizing and directing the Chairman (or other chief executive officer) to execute agreements thereto with the Department of Management Services, for coverage of said General Employees; providing for withholding from salaries and wages of General Employees of Children's Trust of Alachua County so covered to be made and paid over as provided by applicable State laws or regulations; providing that said Children's Trust of Alachua County shall appropriate and pay over employer's contributions and assessments as provided by applicable State laws or regulations; providing that said Children's Trust of Alachua County shall keep records and make reports as required by applicable State laws or regulations: NOW, THEREFORE, BE IT RESOLVED:

Section 1. It is hereby declared to be the policy and purpose of the <u>Alachua County</u>, Florida that all its General Employees except those excluded by law, shall participate in the Florida Retirement System as authorized by Chapter 121. Florida Statutes.

All General Employees shall be compulsory members of the Florida Retirement System as of the effective date of participation in the Florida Retirement System so stated herein.

Section 2. The Chairman (or other chief executive officer) is hereby authorized and directed to execute all necessary agreements and amendments thereto with the Administrator of the Florida Retirement System for the purpose of extending the benefits provided by the Florida Retirement System to the General Employees of this Children's Trust of Alachua County as provided by Section 1 & 2 hereof, which agreement shall provide for such methods of administration of the plan by said Children's Trust of Alachua County as are found by the Administrator of the Florida Retirement System to be necessary and proper, and shall be effective with respect to any employment covered by such agreement for serviced performed on and after the 1 day of October, 2020.

Section 3. Withholding from salaries, wages, or other compensation of General Employees for the purport provided in Section 1 hereof are hereby authorized to be made, and shall be made, in the amounts and at such times as may be required by applicable State laws or regulations, and shall be paid over to the Administrator designated by said laws or regulations to receive such amounts.

Section 4. There shall be appropriated from available funds, derived from <u>ad valorem taxation levied under the authority granted by law and adopted by referendum.</u>

<u>Alachua County</u>, Florida, shall keep such records and make such reports as may be required by applicable State laws or regulations, and shall adhere to all laws and regulations relating to the Florida Retirement System.:

Section 6. The Children's Trust of Alachua County of

Alachua County, Florida, does hereby adopt the terms, conditions, requirements, reservations, benefits, privileges, and other conditions thereunto appertaining, of the Florida Retirement System, for and on behalf of all General Employees of its departments and agencies to be covered under the agreement.:

Section 7. The Executive Director of the Children's Trust of Alachua County of Alachua County, Florida, is hereby designated the custodian of all sums withheld from the compensation of General Employees as authorized herein and of the appropriated funds for the employer's contributions as provided in Section 5 hereof. Also, the Alachua County, Florida is hereby designated the withholding and reporting agent and charged with the duty of maintaining records for the purpose of this ordinance.:

Section 8. This Resolution shall take effect upon its approval and publication as required by law.

BE IT FURTHER RESOLVED that a copy of this Resolution fully executed as in original, duly attested by the Secretary, be furnished to the Administrator of the Florida Retirement System.

General Employees

JOINING PACKET WITHOUT PAST SERVICE

If the Children's Trust of Alachua County (Special District) elects not to purchase past service, the Special District has two available options regarding its existing plan open. First, the Special District has the option of keeping its existing plan open. If the Special District chooses this option, each current full-time and part-time employee filling a regularly established position will need to complete a ballot electing to remain in the Special District's existing plan or join the FRS. Second, the Special District can terminate its existing retirement plan. If the plan is terminated, then all employees filling full-time and part-time regularly established positions would be compulsory FRS members. Under both options, all new hires will be compulsory members of the FRS.

CONTRIBUTION REQUIREMENTS

FRS participating employers shall pay retirement contributions on all covered group employees filling full-time or part-time regularly established positions as defined by Rule 60S-1.004(4), Florida Administrative Code. Employers shall pay retirement contributions to the Division by electronic funds transfer no later than the 5th working day of the month immediately following the month that the payroll ends (for example: the July payroll is due the 5th working day in August). Along with the retirement contributions, employers must submit the retirement file and contribution summary. Employer contributions or retirement file received after the 5th working day of the month shall be considered late and the employer shall be assessed a penalty of 1 percent of the total contributions due.

Employers with employees in the FRS Investment Plan have an additional incentive to report retirement contributions on time, since the employees' retirement benefits are based on the contributions made to their Investment Plan account, plus any gains or losses. Please be aware that Investment Plan contributions are not sent to the employee's account until the contributions are actually paid; therefore a late submission of contributions may negatively affect those employees. In addition to the 1 percent delinquent fee for reporting late contributions, the employer will also be charged loss of earnings on Investment Plan contributions. Data on FRS Online is property of the State of Florida, Department of Management Services. All activity on this website is subject to being intercepted, recorded, read, copied and disclosed by, and to, authorized personnel for official purposes including criminal investigations. Access or use of this website by any person, whether authorized or unauthorized, constitutes consent to these terms.

2. Services Covered:

The agreement includes and covers all services performed by General Employees of this Children's Trust of Alachua County except any service, position, employee, or official excluded by Chapter 121, Florida Statutes, the rules and regulations of the Florida Retirement System, or resolution/ordinance No. 2020-11 adopted by the Children's Trust of Alachua County on the 17 day of August 20_20. The Florida Retirement System is not responsible for nor does it assume any local retirement plan liabilities.

3. Contributions by Employees:

The Children's Trust of Alachua County agrees to impose upon its employees covered by this Agreement the required contributions with respect to wages if such services constituted employment within the meaning of Chapter 121, Florida Statutes, and to deduct the amount of such required contributions from the wages as and when paid. Contributions so collected shall be paid to the Administrator of the Florida Retirement System in partial discharge of the liability of said Children's Trust of Alachua County, said payments to be made in accordance with rules and regulations relating to the Florida Retirement System. It is agreed and understood that the failure of said to deduct such contributions shall not relieve it of liability therefore.

4. Contributions by the Children's Trust of Alachua County:

- (a) The Children's Trust of Alachua County represents that it has duly and legally adopted, and that there is now in full force and effect, a resolution/ordinance requiring an appropriation from available funds in its general or special funds derived from ad valorem tax or other sources, which shall be in an amount not less than the sums withheld as the contributions of employees covered by the Agreement, the sum to equal the total amount due from said Children's Trust of Alachua County (employer's and employee's contributions) under applicable provisions of Chapter 121, Florida Statutes.
- (b) As assurance of its ability to pay its share of the contributions which will become due and payable to the Administrator under the terms of this Agreement and as assurance that said contributions will be adequate, the Children's Trust of Alachua County hereby obligates itself to maintain, and represents that at all times hereafter there will be maintained, in the appropriation provided in paragraph 4.(a), above, a sum fully sufficient to pay its share of the contributions: and that same (together with contributions deducted from salaries, wages, etc., of employees) will be paid promptly when due.

5. Reports-Compliance and Regulations:

26	WHEREAS, the Alachua County Board of County Commissioners established a
27	Children's Services Advisory Board on August 24, 2016, appointed members with advanced
28	expertise in early childhood development, and appropriated funds for innovative and collaborative
29	programs; and
30	WHEREAS, during its meeting of April 12, 2017, the Children's Services Advisory Board
31	took action to formally recommend to the Alachua County Board of County Commissioners to
32	establish an independent Children's Trust and to hold a referendum on the creation of an
33	independent special district; and
34	WHEREAS, the Children's Services Advisory Board has worked to implement a Healthy
35	Baby Nurse Home Visit Program, a Transform Professional Development for Early Care and

- 1 Education Providers program, and has worked to address the social and emotional needs of young 2 children and family supports; and 3 WHEREAS, the Children's Services Advisory Board has determined these innovative 4 initiatives will assure all Alachua County children are ready for success when entering kindergarten; and 5 6 WHEREAS, section 125.901, Florida Statutes, authorizes the County to create an 7 independent special district to provide children's services for all children, from 0 to 18 years of 8 age; and 9 WHEREAS, in 2016 the Board of County Commissioners contracted with the WellFlorida 10 Council Inc., to conduct an assessment of Alachua County children's needs; and 11 WHEREAS, the Children's Services Advisory Board analyzed the needs assessment in 12 detail and discussed its findings; and 13 WHEREAS, the Children's Services Advisory Board concluded that the community can 14 benefit from increased awareness of recognizing the typical stages of growth and development in 15 children birth to age five; and 16 WHEREAS, the very early years of a newborn's brain development is critical to success 17 later in adult life; and WHEREAS, there is a need to help Alachua County residents cope with the stress of 18 19 parenting to assure positive relationships between parents and children, which can reduce the 20 prevalence of child abuse and neglect; and
 - WHEREAS, the needs assessment identified that parents can benefit from knowing what to look for in quality early learning and care services and understanding developmentally appropriate early childhood education including what makes a child "ready for school"; and

1	WHEREAS, a recent study on Racial Inequity in Alachua County identified significant
2	disparity in educational opportunities and concluded that providing a high quality educational
3	experience will lead to a successfully educated resident who will have a higher lifetime income,
4	better employment opportunities, and less likelihood to become involved in the criminal justice
5	system; and
6	WHEREAS, it is the intent of the Board of County Commissioners to create an
7	independent special district with taxing authority if approved by a majority vote of the qualified
8	electors of Alachua County voting in a November 6, 2018 referendum; and
9	WHEREAS, the Board of County Commissioners has determined that it would serve the
10	public interest to establish said independent special district within Alachua County.

12	NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY
13	COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:
14	SECTION 1. Chapter 26, Children's Services Independent Special District, is created:
15	Chapter 26. Children's Trust, Independent Special District.
16	Section 26.01. Creation of an Independent Special District; Creation of Children's Trust.
17	Subject to the approval of a majority of the qualified electors of Alachua County voting in
18	a November 6, 2018, referendum, there is hereby created an independent special district to provide
19	children's services throughout Alachua County. The boundaries of the District shall be
20	coterminous with the boundaries of Alachua County. The governing body of the District shall be

a board of directors to be known as the Children's Trust of Alachua County.

Section 26.02. Membership.

- The Children's Trust shall consist of 10 members, selected as follows:
 - a. The superintendent of schools; a local school board member, chosen by a majority of the School Board of Alachua County; the district administrator from District III of the Department of Children and Family Services, or his or her designee who is a member of the Senior Management Service or of the Selected Exempt Service; one member of the County Commission, chosen by a majority of the Alachua County Board of County Commissioners; and a judge assigned to juvenile cases who shall sit as a voting member of the board, except that said judge shall not vote or participate in the setting of ad valorem taxes under this section. If there is more than one judge assigned to juvenile cases in Alachua County, the chief judge of the 8th Judicial Circuit shall designate which judge shall serve on the board. All of the proceeding members shall serve 4-year terms effective January 1, 2019.
 - b. The remaining five members shall be appointed by the Governor, and shall, to the extent possible, represent the demographic diversity of the population of Alachua County. After soliciting recommendations from the public, the Alachua County Board of County Commissioners shall submit to the Governor the names of at least three persons for each vacancy occurring among the five members to be appointed by the Governor, and the Governor shall appoint members to the council from the candidates nominated. The Governor shall make a selection within a 45-day period or request a new list of candidates. All members appointed by the Governor shall have been residents of the Alachua County for the previous 24-month period. Such members shall be appointed for 4-year terms, except that the length of the terms of the initial appointees shall be for 2 years. The Governor may remove a member for cause or upon the written petition of a majority of the County Commission plus one. If any of the members of the council required to be appointed

Į by the Governor under the provisions of this subsection shall resign, die, or be removed from 2 office, the vacancy thereby created shall, as soon as practicable, be filled by appointment by the 3 Governor, using the same method as the original appointment, and such appointment to fill a 4 vacancy shall be for the unexpired term of the person who resigns, dies, or is removed from office. 5 6 Section 26.03. Powers and Duties. 7 The Children's Trust of Alachua County shall have the following powers and a. duties: 8 9 1. In order to provide funds for the Children's Trust of Alachua County, the council may levy ad valorem taxes annually on all taxable property in the County in an amount not to exceed one-half mill, provided that the authority to levy such taxes has been approved by a majority vote of the electors of the District voting in the Countywide Election to be held in accordance with the requirements of the constitution and the laws of Florida and as set forth in this chapter. The tax shall be assessed, levied, and collected in the same manner and at the same time as is provided by law for the levy, collection, and enforcement of collection of County taxes. All tax money collected under this Chapter, as soon after the collection thereof as is reasonably practicable, shall be paid directly to the Children's Trust by the Tax Collector of the County and all other applicable County officials. The moneys so received by the Children's Trust shall be deposited in qualified public depositories, as defined in section 280.02, Florida Statutes, in accounts specifically for the council and shall be withdrawn only by checks signed by the chair of the council and countersigned by one other member of the council or by a chief executive officer who shall be so authorized by the council. The chair and the other member of the council who signs the council's checks shall each give a surety bond in the amount of \$1,000 for each \$1 million or portion thereof of the council's annual budget, which bond shall be conditioned that each shall faithfully discharge the duties of their office. The premium on such bond may be paid by the District as part of the expense by the council. No other member of the council shall be required to give bond or other security. No funds of the council shall be expended except by check as aforesaid, except expenditures of petty cash account which shall not at any time exceed \$100. All expenditures from petty cash shall be recorded on the books and records of the Children's Trust. No funds of the council, except the

1	expenditure of petty cash, shall be expended without prior approval of the council, in addition to

25	SECTION 2. Inclusion in the Code, Scrivener's Error. It is the intention of the Board of
26	County Commissioners of Alachua County, Florida, and it is hereby provided that the provisions
27	of this ordinance shall become and be made a part of the Code of Laws and Ordinances of
28	Alachua County, Florida; that the sections of this ordinance may be renumbered or relettered to
29	accomplish such intention; and that the word "ordinance" may be changed to "section," "article,"
